Until recently, Mr. Arcadipane served as Chairman of the Board of Trustees of Holy Cross Hospital in Silver Spring, Maryland, one of the largest hospitals in the greater Washington, DC area.

A graduate of Rider College, Mr. Arcadipane thereafter received his M.A. in economics from The Pennsylvania State University (1965). He received his J.D. from Georgetown University Law School (1968), where he participated successfully in the moot court program and clerked for one of the country's leading labor law professors.
